Sign in Members:

Mailing and Copies:

- ~ Adam Smith reported that the copies still have not been completed. If they are not done by Friday (February 10, 2006), Adam will seek other alternatives.
- ~ Jeff King brought up that there is a print shop at Lakeland Village, and that the price would be cheaper than most places.

Sign-up Items:

- ~ It was moved/seconded and passed to purchase the following items for sign-ups:

City Tournament:

- ~ Adam Smith reported that Spokane-South cannot change their dates.
